Combating crime and terrorism in the United States requires a range of strategic weapons, not the least of which is capturing mobile video evidence. Consequently, agencies need a mobile digital video solution that can precisely and securely capture, transfer, store, and manage video evidence. However, with an in-car video system, not only do organizations have a powerful deterrent to crime and a valuable training aid to officers, but also citizens are much less likely to file false complaints about an officer, because they know that incidents are accurately recorded. An International Association of Chiefs of Police study of in-car cameras found that the use of these devices exonerated the officer in 93 percent of complaints when the incident was recorded, and that officer safety was greatly improved. With a Mobile Evidence Capture solution, digital video and audio evidence is collected, uploaded via a secure network, and reliably stored in a robust server-class evidence management system. All evidence is tamper-proof, safeguarded against damage, and immediately available for sharing among agencies or for use in court.

Mobile Digital Video/Audio Recording System

The Mobile Evidence Capture solution's superior image and audio capture system includes cameras and displays, microphones, a digital video recorder (DVR), a video capture application, and solid-state storage, all professionally installed in any vehicle, whether car, boat, or even motorcycle.

All equipment is designed to meet the rigors of a mobile environment and can be specified to include wide-angle cameras, infrared cameras, GPS, and other advanced capabilities. DVRs are equipped with pre-record and post-record features, allowing incidents to be recorded even before the recording system is triggered. A snapshot capability allows officers to capture and transmit images via their mobile data terminals (MDTs) for quick verification of suspects, vehicles, or situations.

Networking

Evidence is uploaded from the vehicle to the evidence management system via an IP network. The networking component is designed based on agency requirements and can be wireless, allowing for automated upload, or a hard connection to a wired network.

Evidence Management System

The evidence management system stores the evidence and metadata files and controls the process by which the digital video data files are administered, managed, accessed, and distributed.

Access to evidence is secured, with all activity restricted, verified, and recorded. The search tool features a user-friendly interface with incident-relevant key fields. The solution can also consolidate digital evidence for cases that contain numerous elements, including multiple mobile videos, digital photos, fixed video, and documents, and can output those elements to a DVD for presentation, with the appropriate and validated chain-of-custody report.

The evidence management system can be configured to link together a number of nodes to form a larger system. Data from multiple precincts or locations can be accessible from any location or only accessible from one main location, depending on the agency requirements.

Throughout this process, the Mobile Evidence Capture solution provides multiple levels of security to ensure file authenticity and chain of custody. Comprehensive use of network security, encryption, address-specific communication, firewalls, username/password, and hierarchical privilege levels ensures that captured evidence retains its integrity.
